# SALES CONDITIONS

## 1) Your visit - your group

**Please use 1 booking voucher per visiting date, per group or per type of participation.**

Payment for the entrance fees is to be carried out by the responsible of the group in cash at the cashdesk of MINI-EUROPE, according to the real number of participants.

Price supplements for guided visits or didactic programs have to be made directly to the guide. Meals have to be paid in the restaurant.

**All bookings for the restaurant, guided visits, didactic programs or combined visits have to be done by written reservation. The booking becomes definitive, only after written confirmation by MINI-EUROPE.**

- When booking we ask you to inform us about the right number of participants. Whenever the number of participants changes with more than 5 participants, the person in charge of the group will inform MINI-EUROPE at least 5 working days beforehand.
- Take into account between one and a half and two hours for a visit of the park.
- The Take into account between one and a half and two hours for a visit of the park.
- The behavior of the pupils remains under the responsibility for the teachers, please, do not leave them without surveillance in the park.
- All our tariffs and descriptions are subject to any modification. Group tariffs and conditions are only valid as of 20 paying participants.

## 2) Special conditions

**Special conditions for groups of adults and seniors :**

1 free accompanying person for a coach, 1 catalogue free per person:  
The tariffs are valid each day.

**Special conditions for schools, youth movements and disabled persons:**

1 free accompanying person and 1 free catalogue for 15 paying participants. Additional accompanying persons pay the same price as the participants.  
The tariffs for schools, youth movements and disabled persons are valid each day.

## 3) Guided visits, Didactic programs, combined visits

**Guided visits :**

**Guided visits must be booked in advance (at least 5 working days prior to the visit) and are subject to the availability of guides.** Guided visits take place in groups of maximum 25 persons a guide. The supplement for the guided visit is €52 for a group of 25 persons. When the group arrives too late, the guide will wait max 30 min. After this period the amount due will be demanded.

**Didactic programs (European class and Europoly) :**

The European class program and the game Europ-oly must be booked in advance (at least 5 working days prior to the visit) and is subject to the availability of guides. The didactic programs take place in groups of maximum 25 persons a group. The program "European Class" is adapted for pupils between 12 and 18 years. The program Europ-oly is adapted for pupils between 10 and 14 years. The supplement for the didactic programs is €62 and €52 for a group of 25 persons. The guide will wait max 30 min. After this period the amount due will be demanded.

**Combined visits :**

Combined visits must be booked in advance (at least 5 working days prior to the visit) and are subject to prior acceptance. The tariffs for combined group visits are valid as of 20 paying participants. The supplements for combined visits depend on the chosen program and are subject to any modification made by any of the participating attractions. MINI-EUROPE can not be held responsible for any modification or adaptation done by any other attraction.

**Day program :**

For "a day with the Brusseleirs", the meal nor the transport is included. An amount of €88 has to be paid to the guide - accomp anying the group in the afternoon.

**Bookings for guided visits, European class programs or combined visits will only be accepted upon presentation of the written confirmation made by MINI-EUROPE.**

## 4) Lunch at MINI-EUROPE

Groups who wish to have lunch at MINI-EUROPE have the choice between two different formulas:

- self-service: the group has the choice between the suggestions of the day. (à la carte)
- special menu's for groups : the group has the choice between different menu's, described in our groups brochure. These menu's have to be booked in advance, we can only serve 1 kind of menu per group (except for the children's menu).

**In case of cancellation or whenever the number of participants would decrease with more than 5 participants, the person in charge of the group should inform MINI-EUROPE by written, (at least 7 working days beforehand). If not, MINI-EUROPE has the right to charge the group for the number of ordered meals.**

**For the smooth running of services, we ask you to respect the agreed hours. In case of delays of more than 1/2 hour, MINI-EUROPE should be informed immediately. MINI-EUROPE can not be held responsible for a bad service if the group arrives more than 1 hour to late without informing.**

Your ordered menus will only be valid upon presentation of the written confirmation by MINI-EUROPE.
